2. Eligibility Criteria:

Bidder must meet the eligibility criteria specified below and must submit documents in support of the same.

a. Bidder if required may visit the GMRT, Khodad to know the exact scope of work and to understand site conditions etc. with prior intimation to Administrative Officer, GMRT Office, Khodad by complying all required formalities including Medical Certificate stating No Covid (Coronavirus) like symptons from a Professional Medical Doctor (MBBS/MD) and he must be fully confident of carrying out the work tendered and bidder to submit certificate of visit as per **Annexure H** with their technical bid in such a case. Bidder who have already visited the site for this job may submit copy of the earlier site visit certificate.

- **b.** The vendor must submit their bid showing their charges for all the items mentioned in the Chapter 7 and rates must be quoted for all the three years, **otherwise the bid will not be considered.**
- c. Bid must be valid for a minimum period of **90** (**Ninety days**) from the due date for submission of bid.
- d. Bidders should submit the list of works carried out by them, giving details of the clients for whom **repairs of ACs are executed**, the value of work order etc. They should submit us, along-with their bids, the copies of work orders for the past **three years**.
- e. Bidders must have valid GST registration No.
- **f.** Bidder must also submit an undertaking that the work have been carried out by themselves and have not been executed on back to back through other agencies.
- g. Successful bidder must be able to submit:-

CHAPTER 1

General Conditions of Contract (GCC)

- 1. **PRICE**: Rates / charges specified in the bid must be firm till the completion of the contract period.
- 2. **TENDER FEE**: All bids must be accompanied by DD towards tender fee as shown on Tender Notice (**non-refundable**) in the form of Demand Draft in favour of "TIFR" payable at Pune and must enclosed alongwith your Techno Commercial Bid.
- 3. **BID VALIDITY**: Bids must be valid for a minimum period of **90 days** from the due date Bids with shorter validity are liable for rejection.

4. CLARIFICATION OF BIDDING DOCUMENTS

A prospective Bidder requiring any clarification of the Bidding Documents shall contact purchaser in writing at purchaser's address specified in the Tender Notice. Purchaser shall forward copies of its response to all those who have acquired the Bidding Documents directly from it, including the query but without identifying its source. Purchaser if deemed necessary will amend the Bidding Documents as a result of a clarification, purchaser shall do so following the procedure under clause relating to Deadline for Submission of Bids will be revised if purchaser feels it necessary.

NCRA-TIFR reserve the right to ask for or to provide any clarification, changes after the release of this tender. Any changes or clarifications provided by NCRA-TIFR may be checked at NCRA-TIFR website www.ncra.tifr.res.in

5. **SUBMISSION OF BIDS**:

PART "I" (Technical Bid) consisting of Technical Bid with Commercial Terms and **PART "II" (Financial Bid) consisting of only Price** shall be submitted in **separate** sealed envelopes duly superscribed with the tender enquiry number, and the due date in bold letters, addressed to the Purchase Officer, National Centre for Radio Astrophysics / Tata Institute of Fundamental Research, Pune University Campus, Ganeshkhind, Pune 411007. The envelopes should be clearly marked on top as either PART "I" or PART "II".

The two sealed covers should be superscribed with the tender Enquiry No., Due Date in bold letters, addressed to the Purchase Officer, National Centre for Radio Astrophysics / Tata Institute of Fundamental Research, Pune University Campus, Ganeshkhind, Pune 411007 and to be delivered by hand/courier at the security Officer of NCRA-TIFR, Pune before due date specified. The technical bid will be opened in the presence of attending tenderers on the due date and time. Tenders submitted / received after due date and time will not be considered.

Bid should be submitted as per prescribed format of NCRA/TIFR. Bidders should quote in figures as well as in words the rates and amounts quoted by them. The amount for each item should be worked out and the total given. All corrections shall be attested by the dated initials of the bidder.

6. In case the PART 'I' and Part 'II' bids are not sealed in separate envelopes the tender will be rejected.

The technical bid should not contain any indication of the price. The bidder should take special care not to mention anything related to pricing and costing aspect of whatsoever nature. The technical bid should include/contain only technical specifications, technical literature, drawing, quantity, manufacturing and delivery schedule, mode and terms of payment, mode of despatch, the quantum and percentage of statutory levies payable by the purchaser as extra and all related commercial terms and conditions for the supply and for the services like erection and commissioning to be rendered by the tenderer. The details of the validity of the tender should also be indicated along with the commercial details.

After scrutiny of Technical Bids, Financial bids of only those bidders who are shortlisted on technical basis will be opened at on later date. The opening date, time and venue will be intimated to the technically successful bidder.

- **PLACING OF ORDER**: Institute reserves the right to place the order for part/full/reduced quantity / reduced period than what is specified in the tender and also reserves the right to split the order on more than one bidder.
- **ACCEPTANCE OF BID**: NCRA shall be under no obligation to accept the lowest or any other quotation received in response to this enquiry and shall be entitled to reject any or all quotations without assigning any reason whatsoever.
- 9. Bid must be signed only by competent authority specifying their name and designation.

Bids containing correction, overwriting will not be considered. Late or Delayed / Unsolicited quotations/offers shall not be considered at all. These will be returned to the firms as it is. Post tender revisions/corrections shall also not be considered.

Bidder should sign on all the pages of the technical bid and the price bid.

Bids not fulfilling above requirements are liable for rejection.

CHAPTER 2

Special Conditions of Contract (SCC)

- 1. SCOPE OF WORK: Refer Chapter 7 Price Bid.
- 2. **CONTRACT PERIOD**: Contract period will be **one year from the date of issue of work** order. Contract can be extended further with mutual agreement for a period of two years, one year at a time if services provided is found satisfactory and there is no change in conditions of contract and the rates quoted in the tender.

3. EMD: Rs. 14,000/-

Should in the form of Demand Draft drawn in favour of "TIFR" payable at Pune.

EMD to be enclosed along with the Technical Bid (Part-I)

3.1 **REFUND OF EMD:**

- (a) EMD of bidders who do not qualify during Technical Evaluation will be released on completion of Technical Evaluation.
- (b) EMD of all technically qualified bidders (Except for L1) will be released after release of order on L1.
- (c) EMD of successful bidder will be released on receipt of Performance Guarantee.

3.2. FORFEITURE OF EARNEST MONEY:

- (a) If any bidder withdraws his tender before the expiry of the validity period, or before the issue of letter of acceptance, whichever is earlier, or makes any modification in the terms and conditions of the tender which are not acceptable to N CRA, then NCRA shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the Earnest Money absolutely. This provision would naturally apply only to the lowest bidder once the earnest money of all the bidder except lowest is refunded.
- (b) If contractor fails to furnish the prescribed performance guarantee within the prescribed period, the earnest money in full will be forfeited.
- (c) In case the contractor fails to commence the work specified in the tender documents on the **Fifteenth day** or such time period as mentioned in letter of award, after the date on which the Engineer issues written orders to commence the work, or from the date of handing over of the site, whichever is later. NCRA shall, without prejudice to any other right or remedy, be at liberty to forfeit whole of the earnest money absolutely.
- (d) If only a part of the work as shown in the tender is awarded, and the contractor does not commence the work, the amount of the earnest money to be forfeited will be worked out with reference to the estimated cost of the work so awarded.
- (e) In case of forfeiture of earnest money as prescribed in (a) to (d) above of any bidder, such bidder shall not be allowed to participate in the retendering process of the work.

4. PERFORMANCE GUARANTEE

Performance Bond is obtained as a back-up surety for fulfilment of obligation by the Contractor after satisfactory completion of the contract.

Form of Performance Bank Guarantee

Bank Guarantee as per prescribed format to be executed from any one of the nationalized banks or Scheduled bank on non-judicial stamp paper of appropriate value.

Quantum & Value of Performance Bank Guarantee

The bidder on whom order will be placed, shall deposit an amount equal to 5% (five percent) of the value of the work including taxes as Performance Guarantee within 21 days of award of work, valid till completion of work plus Two months for proper fulfillment of the Contract. This period can be further extended at the written request of the contractor for a maximum period ranging from 1 to 15 days with late fee @ 0.1% per day, of performance guarantee amount.

In case Performance Guarantee is not submitted order will be cancelled and EMD will be forfeited.

Validity of Performance Bank Guarantee

Bank Guarantee should be valid till at least two months beyond the expiry date of warranty period.

Performance Guarantee Amount will not carry any interest.

5. CRITERIA For Deciding The Successful Bidders:

- a. Rates for all three years will be taken into consideration for arriving at L1.
- b. Appropriate loading will be done for deviation in payment terms.
- c. If the rates quoted by bidder are same for more than one bidder then the bidder getting higher technical capability as assessed by NCRA on various grounds will be the decision criteria.
- d. If this also results in same, then NCRA reserves right to split order suitably among the bidders.
- e. Decision of NCRA-TIFR Pune is final in this regard.
- 6. **METHOD OF PAYMENT**: The payment will be made on monthly basis. You shall submit your bill on 1st of every month for services provided in the previous month duly certified by our Engineer, which will be paid within 7 working days.

7. Indemnity Bond: Successful bidder after receipt of order should also indemnify us on a non-judicial Stamp Paper of Rs. 500/- that in the event of happenings of anything of such nature, it would neither affect the work nor us in any way in respect of all Actions, Acts, Suits, Claims and Demands brought or made against NCRA by your workmen or any other person or persons whomsoever in connection with the works or in respect of any matter or thing done or committed to be done by you in the execution of or in connection with the works notwithstanding that all reasonable and proper precautions may have been taken by you against any loss or damage to the Owner in consequence of any action or suit being brought against NCRA for anything done or committed to be done in connection with the execution of the work. The indemnity given by you as aforesaid shall extend to making good all claims and demands arising out of losses/damages to property of every description and kind, the infringement of any legal right as well as injury or accident to any person resulting in death or otherwise.

The indemnity given by you shall extend to making good all claims and demands arising out of losses/damages to property of every description and kind, the infringement of any legal right as well as injury or accident to any person resulting in death or otherwise.

SAFETY & SECURITY: The Contractor shall be fully responsible for the safety and security of his workmen and staff and will ensure to maintain necessary records for payment and other details as per the prevailing Procedures and Acts. The Contractor shall be fully responsible for any personal injury, accident, death of your personnel and shall take proper precautions against any such loss or damages by taking Workmen Compensation Insurance Policy (WCIP) valid for the full contract period for all the persons you deploy for this work. (If order is placed on you, the charges towards WCIP to be borne by contractor).

Workmen Compensation policy must be taken keeping in consideration of following:

- i Nos. of Labourers and Supervisor deployed for the work.
- ii Place of work: GMRT Khodad Campus /NCRA, Village Khodad, near Narayangaon, Tal. Junnar, Dist. Pune.

Copy of Insurance Policy to be submitted directly to our Engineer, Accounts Section, Administrative Officer and Purchase Section, NCRA. The Contractor should also promptly report in writing to us all cases of accidents and damages. However, irrespective of the cause and place of occurring, during the execution of the work, the Contractor should make adequate arrangements to render all possible aid to the victims of such accidents and damages.

GST: Extra at actuals. Bidder to provide your GST registration number. Also, please note that NCRA-TIFR, Pune does not have any GST registration number being a non-commercial Govt. research and educational institute.
 2% GST TDS will be deducted, if applicable.

10. **INCOME TAX**: For works contracts, as per the instruction of the Ministry of Finance, the Institute shall have right to recover the Income Tax at applicable rates and the amount so deducted will be credited to Income Tax authority. Please provide your Permanent Account Number (PAN) on your invoices.

11 TERMINATION FOR INSOLVENCY

Centre may at any time terminate the Contract by giving written notice to the contractor, if the contractor becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the contractor, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to purchaser.

12 TERMINATION FOR CONVENIENCE

Purchaser, by written notice sent to the contractor, may terminate the Contract, in whole or in part, at any time. The notice of termination shall specify that termination is for the purchaser's convenience, the extent to which performance of the contractor under the Contract is terminated, and the date upon which such termination becomes effective.

The Job that are complete and ready for completion within 30 days after the contractor's receipt of notice of termination shall be accepted by purchaser at the Contract terms and prices. For the remaining Goods/services, purchaser may elect:

- (a) To have any portion completed and delivered at the Contract terms and prices; and/or
- (b) To cancel the remainder and pay to the contractor an agreed amount for partially completed Jobs and for materials and parts previously procured by the contractor.
- TERMINATION OF CONTRACT: If the contractor who has been awarded the work has abandoned the works without any serious reason or deliberately delayed the work or is not carrying out the works under the terms and conditions of this contract, the Engineer reserves the right to terminate the contract at any time by giving written notice to you and you shall not be eligible for any compensation for the same.

In such a case, the Institute shall take over the charge of the works and other materials lying on the works site. The work shall be carried out by employing other persons at your risk and cost. Any difference in the cost which may become payable in all such cases will be deducted by the Institute from your security deposit or other dues.

14. **PROVISION OF CANCELLATION OF ORDER:** The Institute reserves the right to cancel the contract at any time by giving 30 days written notice. Similarly, if the Contractor wishes to withdraw his services he may do so by giving 30 days' notice in writing. Extension of the contract if required may be considered with mutual agreement depending on the need of the Institute and based on the past performance of the contractor.

- 15. **DEPLOYMENT OF LABOUR & MACHINERY:** You shall not employ any person who is below the age of 18 years. You shall furnish sufficient equipment's and labour as may be necessary to complete the work within the time limit shown in the contract.
- 16. **STORAGE OF YOUR TOOLS AND MATERIALS**: You shall make your own arrangements for storing materials during execution of the contract.
- 17. **PROTECTION OF PROPERTY**: You shall be responsible for making good the damages to the existing property if occurred during the execution of work. All such cases should be brought to the notice of the Engineer by you and also to the concerned department and all damages whatsoever done to be made good by you at your own cost.
- 18. **SAFETY & SECURITY:** The Contractor shall be fully responsible for the safety and security of his workmen and staff and will ensure to maintain necessary records for payment and other details as per the prevailing Procedures and Acts. You will be fully responsible for any personal injury, accident, death of your personnel and shall take proper precautions against any such loss or damages. You will provide adequate and necessary safety equipment's for all your workmen.
- 19. **OBSERVANCE OF LOCAL LAWS**: Wherever applicable (particularly for Local vendors), the vendor / contractor shall comply with all law, statutory rules & regulations etc. The vendor/ contractor shall obtain all necessary permits / approval from the local Governing Body, Police, and other concerned Authorities as may be required under law. The vendor /contractor shall pay all types of taxes, fees, license charges, deposits, duties, tolls, royalty or other charges that may be leviable on account of any the operations connected with the execution of this work/ contract

20. **ARBITRATION:**

- 20.1 Purchaser and the contractor shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
- 20.2 If, after twenty-one (21) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either purchaser or the contractor may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract.
- 20.3 The dispute settlement mechanism/arbitration proceedings shall be concluded as under:
 - (a) In case of Dispute or difference arising between purchaser and contractor relating to any matter arising out of or connected with this agreement, such disputes or

difference shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceedings. The dispute shall be referred to the sole arbitrator mutually acceptable to contractor and owner. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this order. Charges of the arbitrator will have to be shared equally by the Contractor and the Purchaser.

- 20.4 The venue of the arbitration shall be the place from where the purchase / work order or contract is issued.
- 21. In case of any interpretational issues arises in this tender, the interpretation / decision of NCRA-TIFR shall be final and binding on the bidder.
- 22 The competent authority on behalf of T.I.F.R. does not bind himself to accept the lowest or any other tender and reserves to himself the authority to reject any or all the tenders received without assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
- Canvassing in connection with this work order is strictly prohibited and the bids submitted by the vendors who resort to canvassing will be liable to rejection.
- On acceptance of the tender, the name of the authorised representative(s) of the vendor, who would be responsible for taking instructions from the Engineer concerned, shall be communicated.
- 25 The contractor shall give complete cooperation for the execution of the works by the other agencies/contractors or the representatives deputed by the Institute, if required to be carried out simultaneously by other agencies while his own work is in progress. The coordination will be effected in consultation with the Engineer of the work.

26 LIEN IN RESPECT OF CLAIMS IN OTHER CONTRACT

- 26.1 Any sum of money due and payable to the Contractor (including the Security deposit / Performance Guarantee returnable to him) under contract may be withheld or retained by way of lien by the Centre against any claim of the Centre or such other person or persons in respect of payment of a sum of money arising out of or under any other contract made by the contractor with the Centre.
- 26.2 It is an agreed term of the contract that the sum of money so withheld or retained under this clause by the Centre will be kept withheld or retained as such by Centre till this claim arising out of in the same contract or any other contract is either mutually settled or determined by the arbitrator, and that the contractor shall have no claim for interest or damages whatsoever on this account or on any other ground in respect of any sum of money with-held or retained under this clause and duly notified as such to the contractor.

27 WITH-HOLDING AND LIEN IN RESPECT OF SUMS CLAIMED

- 27.1 Whenever any claim or claims for payment of a sum of money arises out of or under the contract against the contractor, Centre shall be entitled to withhold and have a lien to retain to the extent of the such claimed amount, from any sum or sums found payable or which at any time thereafter may become payable to the contractor under the same contract or any other contract with the Centre.
- 27.2 It is an agreed term of the contract that the sum of money or money so withheld or retained under the lien referred to above by the Centre will be kept withheld or retained as such by the Centre till the claim arising out of or under the contract is determined by the Arbitrator and that the contractor will have no claim for interest or damage whatsoever on any contract in respect of such with-holding or retention under the lien referred to and duly notified as such to the contractor.

CHAPTER 3

Scope of Work

- 1.1 Repair of the AC's indoor and outdoor units after the parts are replaced and machine are repaired and put into operation shall in general include the following..
 - A) Lubricating the room unit and condenser fan motor and other mechanical parts such as motor mounting bushes, motor/shaft alignment, fan blades/keys etc. while repairing / replacing the fan blades / blowers as required.
 - B) Checking of the electrical connections of the repair related components and ensuring the functional working of electrical Components like compressor, condenser motor, indoor unit motor, PCB etc.
 - C) Cleaning of filters while replacement /repairs of the indoor unit motor/room unit work.
 - D) Checking grill temperature, compressor and motor current and other essential parameters recording and
- 1.2 Reporting/showing them to the Institutes representative or the Engineer concerned.
 - Repairing / rewinding of the failed motors: While repairing the motors the contractor should remove complete burnt windings without damaging the laminations and core insulation, clean the entire surface, slots etc. and rewind motor using super enamel copper wire conforming to IS-4800 (or as per the latest edition) and suitable class of insulation. In no case the class of insulation material used shall be of lower than class `E' as per IS 1271 (latest edition) or used in the motor, subsequently varnish the same with the two coats of reputed make varnish (preferably Dr Beck & Co make ELMO 20S).
 - G) Repairing for the gas leakage: Includes detecting the refrigerant gas leakage point/points in the system, repairing including necessary brazing at the refrigerant circuit / condenser coil / room unit coil or wherever it is noticed with proper vacuuming and pressure testing after rectifying the leak and filling the refrigerant gas to achieve the required temperature and checking the refrigerant gas leakages, gas pressure in the AC machines /system.
 - H) A standard operating procedure, as followed in the industries as a standard practice, shall be followed to attend the above problems.
- 1.3) Replacement of compressors: The hermetically sealed compressor shall be replaced with OEM (Original Equipment Manufacturer) repaired/ new (as the case may be) compressor during the break down. If OEM repaired compressors are not available due to any reason, the contractor has to replace the same with a new compressor of suitable model or as per the instruction of Concerned Engineer or his representative without any additional charge.

The repaired/new compressor should be shown to the departmental representative along with relevant documents before actually fixing it on the machine.

General Conditions:-

2.1) The contractor shall depute adequate technical staff, during the execution of this work, such as supervisors, electrician, air-conditioning mechanics etc. having adequate experience. These staff should be available at site whenever required by the Engineer In-charge or his authorized representative to take instructions and shall be available during and if required after office hours during the period of execution of this contract.

- 2.2) The contractor shall depute during the execution of the work under the contract period only such persons who are careful, skilled and experienced in their respective trades / fields and the Engineer Incharge shall be at liberty to object to and can ask the contractor to remove from the work any persons employed by the contractor during the execution of works who in the opinion of the Engineer Incharge misconducts or is incompetent, or negligent in the proper performance of his duties.
- 2.3) The contractor shall give complete cooperation during the execution of the AC repair works to the other agencies/contractors or the representatives deputed by the Institute, if required to be carried out simultaneously by other agencies while his own work is in progress. The coordination will be effected in consultation with the Engineer In-charge of the work.
- 2.4) NCRA/TIFR/GMRT reserves the right of including or excluding any number of A.C. units into/ from the contract at any time.
- 2.5) On acceptance of the tender, the name of the authorised representative(s) of the vendor, who would be responsible for taking instructions from the Engineer concerned, shall be communicated to the Concerned Engineer.
