MINUTES OF THE PRE-BID MEETING ON Friday, 04 April, 2014 AT NCRA, Pune AT 3.00PM

- The bidders need not have registration with CPWD/PWD/MES/ RAILWAYS Desem etc but must have work experience and financial capability as mentioned in the "Eligibility Criteria".
- 2. No electricity shall be provided by Client to the contractor or for the labour camp. Temporary electrical connection for construction purpose will have to be obtained at their cost by the contractor who will be executing the job.
- 3. Space for labour camp, across the site, shall be provided by the client. Contractor shall have to make arrangements for the water, electricity and conservancy at the camp.
- 4. Site concrete with Mix Design (from agencies like Duracrete) is acceptable.
- 5. Minimum site welding is expected for the roof trusses etc. which should be prefabricated in parts and brought to site. Any welding has be done after obtaining clearance from the client.
- 6. Basic rates for Cement and steel is not given in the tender document as no escalation in cost shall be allowed.
- 7. Bidders shall quote rates without taxes. The taxes (VAT & Service Tax) shall be added to the grand total at the end. The percentage of taxes shall also be mentioned clearly in the covering letter to be submitted in the "Techno-commercial Bid" without fail.

 No LBT shall be paid by the client .
- 9. Use of mobiles is not allowed at the site. Care should be taken by the contractor that the mobiles are not used by the labour in the camp.
- 10. Borewell may be drilled by the contractor at the site at his own cost and risk, with prior approval from the client regarding the location.

 Water may be used for the construction, if found suitable.
- 11. One BSNL landline connection and one intercom connection shall be provided by the client and charges as applicable will have to be paid by the contractor.
