GENERAL INTRODUCTION

INTRODUCTION:

National Centre for Radio Astrophysics – Tata Institute of Fundamental Research Pune, which is one of the National Centres of TIFR wish to invite bids for providing services of Consolidation-Cum-Clearing Agent for the import/export of shipment from anywhere in the world by air/sea. Our consignment comprises of delicate equipment's, instruments and high value active/passive devices, computers & computer peripherals etc.

SCOPE OF WORK:

<u>I</u> <u>CONSOLIDATION OF THE IMPORT CONSIGNMENTS</u>

- 1. You shall provide regular feedback regarding the readiness of our shipment by keeping constant touch with our suppliers once we provide copy of our Purchase Order.
- 2. Follow up with our suppliers to ensure that they send us Order Acknowledgment / Proforma Invoice / details for opening Letter of Credit.
- 3. Before picking up, ensure that the packing used by supplier is adequate to withstand transit hazards till it reaches final destination before they are picked up.
- 4. Checking actual weight of all the packages before taking delivery of shipment from (a) Origin (b) Airlines and (c) W/H authorities. Sorting out the problems in case any difference is noticed between actual weight of shipment and weight shown on the documents.
- 5. Picking up the shipments as per our instruction (all items or part items/qty as per conditions of our Purchase Order) (as per price basis shown on our purchase order Ex-Works / Ex-Warehouse / FOB/FCA) and getting proper packing slip/invoice etc. as per Purchase Order from our suppliers.

- 8. You / Your Agent shall be responsible for safe custody of the shipments from the time they are picked up from our supplier / received from our suppliers at the prescribed place until they are handed over to the Airlines. Similarly after taking delivery after custom clearance till it is delivered at the final destination. You shall submit legal liability insurance policy for carrying our shipment from Mumbai to final destination and vice versa.
- 9. You shall ensure that all our shipments are put on Flight/Ship/Courier within the least possible time.

Whenever you are sending shipments viz. heavy / ODC you shall inform us well in advance to enable us to keep our stores informed. You shall obtain necessary permit and clearance from relevant authorities before sending such shipment. Similarly, for consignment which are to be sent on full truck/tempo load basis to our Khodad office. You shall ensure that your vehicle reaches us before 4.00 P.M. on working days, so as to avoid detention of vehicles till next working day for unloading.

You shall also intimate us in advance charges for hiring of cranes if required for the unloading items at our site.

10. PAYMENT OF FREIGHT CHARGES AND CUSTOMS DUTY:

Successful bidder against our limited tender shall be able to :-

- (a) pay the International Freight Charges in full on each shipment on our behalf and claim reimbursement through their bills.
- (b) shall be able to pay custom duty upto atleast Rs. 2,00,000/- on each shipment on our behalf and claim reimbursement of the same through their bill, enclosing the duty paid challan / receipt.

If the Duty amount exceeds Rs. 2,00,000/- Centre shall make payment of the same to you by NEFT / RTGS within 3 working days after receipt of your email confirming the duty amount together with the Excise Duty calculations. Excess Duty if any received will have to refunded back to us by NEFT / RTGS immediately. However, you shall make payment of duty without waiting for our funds.

If duty amount paid is less than actual duty, you may then pay the difference and claim reimbursement through your bill.

11. PAYMENT FOR YOUR SERVICES:

Payment of your bill for service charges together with other charges viz. CMC Charges, stamp duty, AI/ MIAPL/ CONCOR charges, S Form charges, Custom Duty, Freight amount, delivery charges etc. evidencing receipt of the shipment at delivery point etc. will be paid within 10 working days after receipt of your bill together with original receipts (wherever applicable) by NEFT / RTGS.

- (e) Octroi /LBT is not applicable for direct delivery of shipments at (a) NCRA-TIFR, Pune
- (b) GMRT Office, Khodad & at (b) Radio Astronomy Centre, TIFR Ooty (TamilNadu).

12. CUSTOM DUTY

Centre being a public funded non-profit research organization and under DAE, Govt. of India and hence eligible for availing concessional duty for all items under Customs Notification No. 51/96-CUSTOMS dated 23 July 1996 As Amended Vide Notification No. 93/96-CUSTOMS DTD. 11 December 1996, 19/97-cus dtd. 01.03.1997, 28/98 cus dtd. 02.06.98, 20/2000-cus dtd. 01.03.2000 & 24/2002 dtd. 01.03.2002.

Hence shipments have to be cleared in terms of above notitication and as per amendment which may come up from time to time. At present we are getting shipment cleared on payment of concessional duty of 5% (wherever applicable) against certificate which will be issued for shipment against each order.

- 13. Centre reserves the right to use services of supplier's Freight Forwarders / CONSOL Agent / Courier /Air Post Parcel if required and your services in such case will be limited to only custom clearance of such shipments.
- 14. Centre reserves the right to use services of any Freight Forwarders / CONSOL Agents depending on the circumstances and in such cases only Customs Clearance will have to be done from your end.
- 15. Getting shipments at Mumbai International Airport within a week will be your responsibility (if you are freight forwarder) at no extra cost to us in case any of our shipment lands at any other Airport in India or aboard.
- 16. Center will not be responsible if vendor uses the services of their freight forwarder for shipping the item. In such case you still have to co-ordinate and collect the relevant documents from their Mumbai Office and arrange for Custom Clearance of the shipment. Delay if any on this account cannot be attributed to NCRA.
- 17. Please provide List of your Government clients in Pune / Mumbai.
- 18. Please find List of our suppliers with their full addresses from whom we have imported items in the past in **Annexure V** for your information.
- 19. Being an R & D Institute it will not be possible for us to quantify the number of transactions. However data in receipt of import orders placed in the past three years is shown below for your reference:

Value of import not given since we will be paying service charges for customs clearance only on fixed rate basis and not on % of CIF value of shipments.

For the sake of estimate our import transaction per month will be 2-4, sometimes it may so happen that 4-5 consignments may arrive at a time.

- 20. Centre will not pay any amount towards demurrage on account of any reason and same will have to be borne by you if payable.
- 21. All our shipments arriving at Mumbai have to be cleared on top priority. All efforts should be made to clear the shipments within the free period without paying any demurrage. However, if any demurrage is paid on account of any reason, NCRA will not be reimbursing the same which please note.

- 22. You will have to arrange (as and when required) for collection of all clearance documents from NCRA, Pune at no extra charges.
- 23. The successful bidder will have to give an undertaking that no shipments of NCRA-TIFR, Pune will be detained / withheld by them, after they are picked up or after the clearance under any circumstances.
- 24. The bidder should have their own arrangements for warehousing, insurance, pick-up and delivery of the shipment by road within the country and also in the exporting country.
- 25. You shall be responsible for the safety of our cargo in all circumstances.
- 26. You shall take full precaution and care and must be physically present if any of our shipments are opened for customs examination. You should also ensure that proper repacking is done in such cases so that there is no room for theft when the shipments are in the custody of customs/port authorities and as well as during transportation to respective destinations viz. GMRT Office, Khodad or NCRA, Pune or RAC, Ooty.
- 27. If any theft/burglary or anything of such nature is occurred during or after taking the delivery of any consignment from customs and while transporting it to our premises, you shall immediately lodge an F.I.R. with the nearest police station and send us a copy of the same. But in all such cases your responsibility will not cease unless we reach a settlement.
- 28. The repacking charges (after the customs examination) at actuals can be reimbursed to you only when new packing case/box is required.
- 29. You shall preserve the original wrapper of the consignment in case any further repacking is required to be carried out and ensure that the original packing wrapper is kept inside the repacked parcel.
- 30. You shall take full responsibility (after the consignments are cleared/taken out of customs charge) for safe storage and proper handling of packages during transportation till the packages are delivered at our premises.
- 31. You shall have to arrange to deliver our consignment through your own vehicle or through your authorized transporter immediately after clearance at Mumbai on freight paid door delivery basis to our premises.
- 32. You shall also be responsible for complying with S-Form formalities of Mumbai & also to respond to their notices (if any) properly in writing under intimation to us and get their acknowledgement.
- 33. You shall also be required to handle customs clearance & export of wrongly received items and items to be sent for repairs / calibration etc. abroad and for clearance of the same after reimport. In such cases you will keep full record of all export documents so that no problems arise at the time of re-import.

- 34. The consignment should be cleared as fast as possible. In case more time is required to clear any consignment for any reason beyond your control you must inform us accordingly by email/fax citing the reasons.
- 35. In case you envisage any delay in clearance of heavy and high value consignment of ours, you will have to arrange for shifting the consignment to a Govt./private bonded warehouse under customs supervision to avoid payment of heavy demurrages to port authorities.
- 36. Wherever any particulars are required by customs such as Data Sheet, Catalogue, Invoice etc. to clear the consignment you will immediately bring such matter to our notice by phone/email/fax so that we can send you the required documents/particulars.
- 37. Please note centre may obtain an open marine policy (anywhere in the world to anywhere in the world) for covering all our imports & exports on W/H to W/H basis and copy of the same will be given to you.
- 38. You shall use only Closed Body vehicle with shutter with lock and key for delivering shipments at NCRA Pune & GMRT Office, Khodad near N'gaon (Tal. Junnar).
- 39. Our Inco terms with our suppliers is normally Ex.Works/Ex.W/H or FCA Gateway Airport, however, sometimes supplier may quote on CIF or CPT basis or any other terms convenient to them.
- 40. Origin of Cargo may be anywhere in the world. However, many of our shipments comes from USA or Singapore.
- 41. Most of our shipments comprises of Electronic components and hence are of less weight ranging from 1 kg to 20 kgs also of small dimension boxes. Value may vary from few hundred US Dollars to few thousand US Dollars.
- 42. Occasionally there can be shipments of large size & weights and value which we may decide to get by Air or Sea.
- 43. Normally our items for import are not appearing in the negative list of import policy. However, if you find any item in our import order requiring any special permission, you shall inform us immediately.




