## 1. Replies to Bidder Queries:

The queries received from bidders through e-mail and during the meeting held on 17.10.2025 have been duly examined. The consolidated replies to all queries are enclosed as **Annexure-A** (Page 01 to 6) of this corrigendum for information of all concerned bidders.

2. Inclusion of Clause – Limitation of Liability (LoL):
The following clause is hereby included in the tender document as a part of ATC Clause.

#### LIMITATION OF LIABILITY:

- 2.1 The Supplier shall be excused and not be liable or responsible for any delay or failure to perform to Deliverables under this contract to the extent that such delay or failure has arisen as a result of any delay or failure by the Buyer (NCRA) or its employees or agents or third-party service providers, to perform any of its duties and obligations as set out in these tendered items. In the event that the Supplier is delayed or prevented from performing its obligations due to such failure or delay on the part of or on behalf of the Buyer, the Supplier shall be allowed an additional period of time to perform its obligations and unless otherwise agreed the additional period shall be equal to the amount of time for which the Supplier is delayed or prevented from performing its obligations due to such failure or delay on the part of or on behalf of the Buyer. Such failures or delays shall be brought to the notice of the Buyer, and subject to mutual agreement with the Buyer, the Supplier shall take such actions as may be necessary to correct or remedy the failures or delays.
- 2.2 The Supplier shall be entitled to invoice the Buyer for additional costs incurred in connection with the correction or remedy as above as agreed herein, after mutually agreed by the Buyer. Neither party shall be liable to the other for any special, indirect, incidental, consequential (including loss of profit or revenue), exemplary or punitive damages, whether in contract, tort or other theories of law, even if such party has been advised of the possibility of such damages, subject to other terms of the tender.

- 2.3 The total cumulative liability of either party arising from or relating to this job shall not exceed in the aggregate the total amount paid to Supplier by the Buyer during contractual period immediately preceding the claim that gives rise to such liability (as of the date the liability arose); provided, however, that this limitation shall not apply to any liability for damages arising from (a) wilful misconduct and wilful negligence or (b) indemnification against third party claims for infringement.
