INSTRUCTIONS TO BIDDERS and SCOPE OF WORK

GMRT-NCRA provides medical facilities including the supply of medicines to its employees (serving & retirees) and their dependent family through its medical scheme, namely NCRA Contributory Medical Scheme (NMS). Under this Scheme, beneficiaries are entitled to medical consultation (from the Institute's Medical Officer and empanelled hospitals) and supply of medicines, drugs and surgical etc.

GMRT-NCRA aspires to timely distribution of the medicines to all its beneficiaries. In this context, NCRA-GMRT invites bids for supply of medicines, drugs and surgical etc. to all its beneficiaries from the reputed chemist having shops located in Narayangaon, Tal. Junnar, Dist. Pune – 410504.

The empanelled chemist will supply allopathic, proprietary medicines/drugs/surgical items of the same brand name (no substitution) at the agreed uniform rate of discount on MRP (inclusive of all taxes), within the stipulated time, against endorsed prescriptions (prescribed by the treating doctor and endorsed by Administrative Officer, GMRT/Medical Officer, GMRT).

We invite Expressions of Interest (EOI) from well-established and licensed medicine suppliers/pharmacy/medical shop operators located in Narayangaon, for the dispensing of medicines to beneficiaries of the NCRA Medical Scheme (NMS).

- a) The selected agency shall be required to dispense medicines, drugs and surgical etc., on all working days including Sunday and Closed Holidays (if required and as per Emergency Case), at discounted rates.
- b) The EOI is being invited through the Central Public Procurement Portal (CPPP) from eligible and licensed medicine dealers located in Narayangaon only. Selection will be based on the highest percentage discount offered on the Maximum Retail Price (MRP) of medicines and related pharmaceutical items, subject to compliance with the terms and conditions of the EOI.
- c) The successful party will be decided among the parties who accept the Terms and Conditions as mentioned in the successive paragraphs and who offer the maximum discount on the retail price of the Medicine and other medical-related items. If finalised, the successful party will have to enter into an agreement/contract with NCRA-TIFR. This agreement will be for a total period of one year at a time.
- d) The Chemist/ Medical Store/ Medicine dealer or his representative shall always be contactable/approachable over phone and otherwise on all days. The vendor should have an official email ID and official contact number
- e) Interested suppliers shall quote a uniform percentage discount on the MRP applicable to all categories of medicines and medical supplies. The selected supplier shall be responsible for payment of all applicable taxes, duties, levies, and other statutory charges as per prevailing laws. The supplier shall also bear all expenses related to packaging, handling, transportation, delivery, and any other incidental costs associated with supplying medicines and medical items to locations specified by NCRA-TIFR.
- f) NCRA-TIFR shall make payment based on the printed MRP of the supplied items, less the discount offered and accepted under the contract. The quoted discount percentage shall remain firm and valid throughout the entire contract period.
- g) The selection of the Medicine Supplier will be based primarily on the maximum percentage discount offered on the MRP of medicines and related medical supplies, subject to fulfilment of all eligibility criteria and terms and conditions specified in the EOI document.
- h) The Centre Director, NCRA-TIFR Pune reserves the right to accept or reject any or all applications/offers, either wholly or partially, without assigning any reason whatsoever. The decision of NCRA-TIFR in this regard shall be final and binding.

- i) Only those Medicine Suppliers who satisfy the prescribed eligibility criteria and agree to comply with all terms and conditions contained in the EOI document shall be eligible to participate in the process.
- j) Sufficient stock of standard requirement/commonly used medicines, their quantity and quality at all times will have to be maintained by the chemist, to avoid inconvenience to the NMS beneficiaries
- k) The commonly used, generally required medicines etc. prescribed/indented drugs shall be supplied in full on the same day to the beneficiary at the agreed collection centre (usually GMRT Colony Main Gate, Narayangaon). In case the prescribed medicines are not available readily (only in case of commonly used, generally required medicines etc.), the chemist shall make them available and supply to the beneficiary on the same day.
- l) The prescribed medicines (special ailment medicines and not commonly used, generally required medicines), if not available with the chemist, the chemist shall make them available within 24 hours after collecting the prescription. If, the chemist could not make it available and the beneficiary purchases it from any other medical shop, the quoted discount shall be collected from the panelled chemist for the cost of the medicines purchased from the other medical shop and a penalty of Rs.100/- per occurrence of non-supply will be imposed in addition to the discount. This will be done at the time of bill payment/settlement.
- m) In case of emergency, the prescribed/indented drugs shall be delivered at the residence of the beneficiary by the chemist, as directed by the Administrative Officer, GMRT/Medical Officer, GMRT or else the beneficiary may collect the authorised item(s) from the chemist's shop.
- n) Tampering with the printed MRP, batch no., manufacturing and expiry dates etc. of the manufacturer by the chemist by use of a sticker or by any means will not be accepted and the item shall be rejected.
- o) No toiletry or food substitute is reimbursable. Protein substitutes, sun-screen creams, skin softeners, Vit.-E creams, Aloe-vera creams etc. will not be allowed to be dispensed under the contract.
- p) Any expired/spurious/sub-standard medicine or tampering of MRP/packing may lead to rejection, penalty, and debarment/blacklisting in addition to other administrative action.
- q) NCRA-GMRT reserves the right to draw random samples of medicines supplied under this Contract and get them tested through NABL- accredited labs / Government labs at its discretion. Where any sample fails testing, the chemist shall bear the testing cost, recall the affected batch/lot, replace/compensate as directed and such failure may attract penalties.
- r) The panelled chemist shall dispense the medicines to the beneficiary by ensuring the endorsement by the Administrative Officer, GMRT/Medical Officer, GMRT.
- s) The panelled chemist shall dispense the prescribed medicines, drugs etc. only and shall take the signature of the beneficiary on the medicine bills to confirm the delivery of the items, failing which the bills will not be settled.
- t) Bids quoting less than 15% discount on MRP (inclusive of all taxes) shall not be considered.
- u) Bids NOT submitted as per the specified format and nomenclature will be out rightly rejected.
- v) Conditional bid will be out rightly rejected.
- w) The bidder(s) will be ranked in order of highest to lowest discount (in descending order) and termed as H1; H2; H3 and so on.
- x) The order will be issued to the H1 i.e. highest discount bidder.
- y) In case of indent for specific brand of medicines, the brand shall not be substituted. If any such case is complained by the beneficiary/noticed during subsequent scrutiny after or before the payment, the chemist will be penalized for Rs. 500/- along with the cost of the specific brand of medicines for each such default.

Stamp and Signature of the Bidder

- z) For medicines requiring cold-chain / refrigerated storage (e.g., 2-8°C or as per label), the chemist shall maintain an uninterrupted cold chain during storage, packing and transport, using validated insulated shipper/cold box packaging with gel packs and temperature monitoring. Cold-chain packing and handling shall strictly follow applicable Good Distribution Practices (GDP) / cold-chain norms and the manufacturer's instructions. Any suspected temperature excursion shall be recorded and such supplies may be rejected at the discretion of the office.
- aa) The chemist shall issue medicines not more than 3 months at a time (applicable for continued/long term treatment e.g. Diabetes, Blood pressure complaints etc.), after endorsement by the Administrative Officer, GMRT/Medical Officer, GMRT.

1. Eligibility Criteria

- **1.1** The Medicine Supplier should be a Proprietary Firm / Partnership Firm / LLP / Private Limited Company / Limited Company etc. registered with the appropriate authority.
- **1.2** A valid PAN and GST Registration certificate should be available with the Medicine Supplier.
- **1.3** The Medicine Supplier must hold valid licenses as on the date of bid issued by the Drug Control Authority of the Maharashtra State under the provisions of the Drugs and Cosmetics Act, 1940. They must hold all other licenses, clearances and permissions as may be necessary to carry out the trade of dealing with / sealing of medicines. The Medicine Supplier should possess a valid license during the contract period.
- **1.4** The bidder must have a full-fledged outlet/shop/establishment in Narayangaon for the last one year.
- **1.5** The Medicine Supplier must not have been convicted by the State Drugs Authorities and no case should be pending under the Drugs and Cosmetics Act and Rules.
- **1.6** The average annual financial turnover of the Medicine Supplier during the last three years ending on 31.03.2025 should be at Rs. 3 Lacs (Rupees Three Lakhs Only) as per the audited balance sheet and profit & loss account of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant. The net worth of the bidder firm should not be negative as on 31.03.2025.
- **1.7** The Medicine Supplier should not have been indicated for any criminal, fraudulent or corruption activity / blacklisted/debarred by any Central/State Govt./Semi Govt./ PSU/ Autonomous body.
- **1.8** The Medicine Supplier have a functional computerized billing system capable of generating itemised bills (Medicine Name, Batch No, Expiry, MRP, Discount and Net Amount.
- **1.9** Bid must be valid for a minimum period of 60 days from the due date for submission of the bid.
- **1.10** The bidder must understand and agree to the terms and conditions of the "Scope of work" document. Scanned copy of "Tender Acceptance and Declaration of Bidder" as per Annexure __ duly signed by the authorised signatory should be uploaded.

2. Delivery of Medicines & Logistics

- **2.1 Collection:** The panelled chemist or his representative shall receive medical prescriptions/indents, from the agreed collection and dispensing centre (usually GMRT Colony Main Gate, Narayangaon), prescribed by the treating doctor and must be endorsed by the Administrative Officer, GMRT/Medical Officer, GMRT during the time allotted, say, 10am, 12pm, 3pm, 6pm on the day (these timings are provisional only and final collection time will be decided on the mutual agreement and convenience of the GMRT-NCRA beneficiaries). "Failure to collect prescriptions for two consecutive slots without prior intimation shall be treated as a service lapse."
- **2.2 Timelines:** "In case of 'Life-Saving' or 'Urgent' remarks by the Medical Officer (MO), the pharmacy must deliver the medicine within **30 minutes**, regardless of the routine collection schedule."
- **2.3 Home Delivery:** If a prescribed medicine cannot be supplied within the 60-minute window for whatsoever reason, it must be delivered to the beneficiary's residence by the following day at **no extra cost**.
- **2.4 Substitution:** Strictly prohibited. In exceptional cases, substitution requires prior written approval from the MO, GMRT Panelled MO, GMRT-NCRA.
- **2.5 Direct Sales:** Non-prescribed medicines requested by beneficiaries must be billed and collected separately from the individual; GMRT-NCRA bears no responsibility for these payments.
- **2.6 Stocking:** The pharmacy shall maintain adequate stock of commonly prescribed medicines to ensure a 0% stock-out rate.
- **2.7** In case of emergency or at a time other than the time allotted, the beneficiary may directly reach the panelled chemist's shop with the medical prescription by the treating doctor, duly endorsed by the Administrative Officer, GMRT/Medical Officer, GMRT, for collecting the medicines, drugs etc.

3. Billing & Payment System

- **3.1 Submission:** Computerised bills must be submitted with original prescriptions and beneficiary acknowledgements.
- **3.2 Cycle:** OPD bill statements must be submitted to the Administrative Officer, GMRT on the **10th, 20th, and 30th** of every month.
- **3.3 Payment:** Payments will generally be released via NEFT/Cheque within 30 days of correct document submission.
- **3.4 Transparency:** The agreed discount must be explicitly indicated on every bill.
- **3.5 Price Protection:** In the event of a reduction in MRP by the Government/NPPA, the benefit must be passed on to GMRT immediately.
- **3.6** Bills with manual corrections, overwriting, or fluid erasures will be summarily rejected. All discounts must be calculated on the **current MRP** at the time of sale.
- **3.7** The bill produced to the beneficiary/office should clearly indicate the details of the supplies made each day such as name of the item, name of manufacturer, batch No., date of manufacture & expiry date, name of the beneficiary/beneficiary ID No. with date, rate, GST (bifurcation, SGST, CGST etc.), total after discount, as per the contract etc. and any other information required by the office. The receipts of bills from the beneficiaries need to be attached to the bill presented by the chemist, failing which the bill will not be considered and will not be paid.

4. Quality, Ethics & Storage

- **4.1 Standards:** Medicines must strictly conform to the brand/quality specified. **No generic medicines are allowed** unless specifically endorsed by the MO.
- **4.2 Counterfeit Policy:** Supply of spurious or expired medicines will result in **immediate termination** and reporting to statutory authorities.
- **4.3 Cold Chain:** Thermolabile medicines (Insulin, etc.) must be delivered in validated cold-chain containers.
- **4.4 Confidentiality:** All patient and transaction data are strictly confidential.
- **4.5 Personnel:** "Pharmacists deployed for GMRT duties must be qualified (B.Pharm/D.Pharm) and registered with the State Pharmacy Council. Their conduct must align with GMRT-NCRA's workplace decorum."
- **4.6. Random Testing:** "GMRT-NCRA reserves the right to send samples of supplied medicines for independent lab testing. Costs shall be borne by the pharmacy if the supplied medicine found not meeting the prescribed standard."

5. Return of Medicines

- **5.1 Eligibility for Return:** The pharmacy shall accept returns of sealed, undamaged medicines in cases of:
 - (a) Change in prescription by MO,
 - (b) Adverse reactions, or
 - (c) Death of the beneficiary.The medicines will be returned to the bidder within 15 days from the above incidences.
- **5.2 Expiry Protection:**
 - Every medicine has its own shelf-life period mentioned on the label of medicine. The shelf life of medicines supplied should not have passed more than half of its shelf life at the time of supply. If supplied, the pharmacy is liable to replace it or issue a credit note.

- **5.3 Processing:** Returns must be processed within 15 days, and a Credit Note must be issued to be adjusted in the next billing cycle.

6. Penalties & Service Compliance

- **6.1 Delay:** Late delivery beyond stipulated times shall attract penalties as per NCRA norms.
- **6.2 Non-Supply:** Failure to supply a prescribed medicine within 24 hrs from collection of prescription will attract a penalty of **minimum 20% of the MRP**. GMRT-NCRA reserves the right to purchase unsupplied medicines from open markets at the **bidder's risk and cost**.
- **6.3 Warning System:** "Three written warnings within a quarter shall lead to a mandatory review of the contract by GMRT-NCRA Administration, which may result in termination."
- **Graded Penalty Scale:**
 - *Delay in Delivery:* 0.5% of the bill value per hour of delay.
 - *Failure to supply:* Failure to supply a prescribed medicine within 24 hrs from collection of prescription will attract a penalty of **minimum 20% of the MRP**.
 - *Wrong Medicine Supply:* Flat penalty of Rs. 200/- per instance plus immediate replacement.
 - *Incomplete Billing:* Deferment of the entire batch payment until rectification.

7. Administration & Dispute Resolution

- **7.1 Finality:** Any dispute shall be resolved amicably; failing which, the **decision of the Competent authority at NCRA-TIFR shall be final and binding**.
- **7.2 Medico-Legal:** Any medico-legal matters arising from supplied drugs must be handled by the bidder at their own cost.

GENERAL GUIDELINES TO BIDDERS ON CPPP E-PROCUREMENT MODULE

1. Procedure for Registration by the Bidder

- 1.1. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link "Click here to Enroll" on the CPP Portal.
 - 1.2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
 - 1.3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
 - 1.4. Upon enrollment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
